Historic Opportunity to Strengthen Renters' Rights: Show Support and Submit Your Comments by July 31!

Historic Opportunity to Strengthen Renters' Rights: Show Support and Submit Your Comments by July 31!

Renters and advocates have a historic opportunity to strengthen federal renter protections. The Federal Housing Finance Agency (FHFA) issued a Request for Input (RFI) on how the agency can create and enforce protections for renters living in homes with federally backed mortgages. Because more than 12 million renters live in properties with federally backed mortgages, any renter protections enacted by FHFA could cover a significant share of renters across the nation and put the United States on a pathway towards stronger protections for all renters.

Advocates have until July 31 to weigh in with FHFA and urge the agency to adopt strong renter protections. You do not need to be a policy expert to submit a comment! FHFA staff are interested in hearing renters' personal stories and perspectives on how new protections would improve their housing stability. Feel free to use NLIHC's sample comment letter and resources from tenantcomment.org to craft your comment, and submit on FHFA's online portal here.

NLIHC is also collecting organizational signatures on a national support letter, which focuses on four priorities:

source-of-income protections, just cause eviction standards, anti-rent gouging protections, and habitability standards. Add your organization to NLIHC's letter here!


Join a Steering Committee!
