Get Involved in Your Affordable Housing Network!

Homeless numbers are rising as over 600 evictions are being filed a week in Wisconsin Courts. The need remains so great. While the state legislature just passed important housing legislation, what percent of the units will be for people earning 30% or less than area median income where the crisis is most acute? According to the National Low Income Housing Coalition (NLIHC), a housing wage of \$20.32 is needed for a worker to afford a market-rate 2-bedroom unit in Wisconsin.

We are moving our Main Meeting to Quarterly with the next meeting scheduled for September. We are considering if we need to change the time from the first Thursday of the month at 9 a.m. What are your thoughts? Also, we are trying to expand our steering committee and launch a subcommittee on a WI Housing Plan. Our Plan will offer a comprehensive blueprint for housing in Wisconsin.

We will be announcing our new name at the A Home for Everyone Conference.

Meanwhile, our affordable rental housing, home ownership, and technical assistance committees continue to meet. Please sign up if you are interested here. Our co-chairs recently met with Elmer Moore, the CEO of WHEDA. and had a fascinating conversation about the future of affordable housing in Wisconsin. Our Curds of Wisdom lunchtime conversations conducted the second session of the zoning and fair housing presentation. We are gearing up for our next series, starting in September on the challenges of building and managing good developments. We are still fine-tuning our subjects and content, so please hit us up with your ideas.

If we come together with our best ideas and innovations, we can move the debate on permanent affordable housing forward amid our housing crises.

WHEDA Foundation 2023 Housing Grants

The application cycle for the 2023 Housing Grant Cycle is now open. (Click Here For Details) The Wisconsin Housing and Economic Development Authority (WHEDA) and the WHEDA Foundation, Inc. make available annual grant funds through the Housing Grant Program competition. The Program's mission is to assist in the improvement of the state's housing for special needs populations such as veterans, physically impaired or disabled persons, domestic abuse victims, runaways, homeless persons, and more.

A total of \$2,000,000 will be awarded for the 2023 cycle with awards to be announced in December. The maximum individual grant award is \$50,000 per project. The grants are for physical improvements such as rehabilitation, accessibility features, and new construction.

Who Can Apply?

- Nonprofit organizations or cooperatives organized under Chapters 181, 185, or 187 of the Wisconsin Statutes
- Community development, redevelopment, and housing authorities
- Local units of government
- Native American tribal authorities

Important details:

- The competition includes two separate housing categories: Emergency/Transitional housing and Permanent housing.
- Applicants may apply for grant funds in each category however they may only submit one application per category.
- The maximum individual grant award is \$50,000. There is no minimum award and small funding requests are allowed.

- For flexibility in awarding grants to the "best of the best", more or less than 50% of the funds may be allocated to each category depending on the quality of applications. However, no category will be allocated less than 25% or more than 75% of the total pool.
- Applications are due on August 11, 2023, by 11:59 p.m.
- Grant Awards will be announced in December 2023.
