## McKinney-Vento Homeless Assistance Act

- The intent of the McKinney-Vento Homeless Assistance Act is to ensure all children and youth experiencing homelessness receive access to the same free, appropriate public education as provided to other children and youth.
- As part of the McKinney-Vento Act, all school districts are required to remove barriers to the enrollment, attendance, and the academic success of children and youth experiencing homelessness.

## **Homelessness Defined**

The term "homeless" children and youth means:

"Children who lack a fixed, regular, and adequate nighttime residence—"

What exactly is a fixed, regular, and adequate nighttime residence?

# Fixed, Regular, and Adequate

#### Fixed:

- Stationary, permanent, not subject to change

#### Regular:

- Used on a predictable, routine, consistent basis
- Consider the relative permanence

#### Adequate:

- Lawfully and reasonably sufficient
- Sufficient for meeting the physical and psychological needs typically met in a home environment

Can the student go to the **SAME PLACE** (fixed) **EVERY NIGHT** (regular) to sleep in a **SAFE AND SUFFICIENT SPACE** (adequate)?

- i. Sharing housing due to loss of housing, economic hardship, or similar reason; hotels, trailer parks, or campgrounds due to lack of alternatives; emergency or transitional shelters; abandoned in hospitals
- ii. Primary nighttime residence is a public or private place not designed for ordinarily used as a regular sleeping accommodation for humans
- iii. Living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings
- iV. Migratory children who meet clauses (i) through (iii)

# **Unaccompanied Youth**

Unaccompanied children and youth whose living arrangements meet the McKinney-Vento definition of homeless are eligible for services under the Act. The term unaccompanied youth is defined in the Act as "a homeless child or youth not in the physical custody of a parent or guardian" [42 U.S.C. § 11434a(6)].

# **McKinney-Vento Supports**

- Free meals under the National School Lunch and School Breakfast Programs
- Fees waived for school programs and extracurricular programs
- Referrals for additional supports (Head Start, child care, health care, dental, mental health, substance use, housing and other appropriate services)
- Unaccompanied homeless youth can be an independent student for FASFA
- Transportation to the school the student attended before experiencing homelessness (school of origin)







### **School District Homeless Liaisons**

Every school district must designate a McKinney-Vento homeless liaison able to carry out their legal duties.

The local liaison serves as one of the primary contacts between families experiencing homelessness and school staff, district personnel, shelter workers, and other service providers. The liaison coordinates services to ensure that children and youth experiencing homelessness enroll in school and have the opportunity to succeed academically.
