BSHA is partnering with WISCAP on its Advocacy Day. The primary focus of the day will be supporting the Wisconsin Opportunity Act. While the Blueprint of Wisconsin Housing is in its initial stages, the housing component of the Wisconsin Opportunity Act (AB 600; SB 557) expresses BSHA priorities. That is a focus on creating and preserving affordable housing for Wisconsin's lowest-income renters and homeowners. Partnering with WISCAP allows BSHA to participate in an established advocacy day that will help educate the alliance on how to run an effective day, support good housing legislation, oppose harmful legislation, and build relationships and our identity as a network for the future.

WISCAP's State Legislative Agenda promotes Access to Affordable Housing and Shelter, including:

Creation of a rental assistance program for individuals and families who have suffered an economic hardship with household income up to 80% of the County Median Income. (Up to \$10 million)

Increase the Supply of Affordable Housing. Passage of legislation (AB 619/SB 576) to establish a revolving loan program administered by the Wisconsin Housing and Economic Development Authority (WHEDA) to increase the supply of workforce housing by housing authorities and community-based organizations.

Reduce discriminatory barriers to housing access and affordability. WISCAP supports the advancement of policies to extend housing access, reduce discrimination in housing, and empower tenants to advocate on their behalf.

Specifically, the Wisconsin Opportunity Act (WOA) supports:

- Additional funding for the Critical Assistance Program
- Additional funding for the Housing Assistance Program
- Creates a rental assistance program for individuals and families who have suffered an economic hardship with household income up to 80% of the County Median Income. (Up to \$10 million)
- Establish within WHEDA a pilot program for homeless families with children.

We want to support the WOA (<u>WOA Summary</u>) and meet with key housing committee representatives in the Assembly and Senate sharing our priorities with our elected representatives.

Legislators need to know our agenda and priorities. Our survey of member priorities and our work over the last year lists these priorities.

The legislative session will conclude on February 28. The most damaging items will be vetoed, but we are tracking the Criminalization of Homelessness effort and "pay for success" bills currently working through the legislature (Assembly Bill 689 and Senate Bill 669).

In terms of positive legislation, Habitat for Humanity's bill (<u>AB 619</u>, <u>SB 576</u>) would create a \$100 million workforce housing program to address the significant shortage of homes in Wisconsin. Funding for this bill would come from General Purpose Revenue and has the potential to attract bipartisan support. A key aspect of this bill would allow first-time homebuyers with incomes up to 120% of area median income (AMI) to use this program.

Support Health Care for Wisconsin's Unaccompanied Homeless Youth

SchoolHouse Connection is working with the Wisconsin Association for Homeless and Runaway Services (WAHRS) in support of <u>SB 704</u> and its companion bill <u>AB 729</u>. These bills would provide the <u>more than 2,000 unaccompanied</u> <u>youth</u> experiencing homelessness in Wisconsin with access to independently consent to their own medical, dental, and mental health care, which is critical to their well-being.

Unaccompanied youth, defined as individuals under 18 without a parent or guardian in their lives and experiencing homelessness, often find themselves in this situation due to factors such as poverty, family instability, or dysfunction. Notably, they are not under the care of the child welfare system. Current laws mandating parental consent, unfortunately, hinder physical and mental health care providers from delivering the necessary treatment to these unaccompanied youth.

Passing SB 704/AB 729 would allow Wisconsin to join 34 other states, including Indiana and Minnesota, that have laws allowing minors experiencing homelessness and on their own to consent to routine care.

Reforming LIHTC to Serve Renters with the Greatest Needs: A Call to Action

After months of negotiation, Senator Ron Wyden (D-OR) and Representative Jason Smith (R-MO), who lead their respective chambers' committees with jurisdiction over tax issues, released <u>bipartisan legislation</u> to expand the Child Tax Credit, extend expiring corporate tax provisions, and expand the Low-Income Housing Tax Credit (LIHTC). The package, however, does

not include <u>key reforms</u> that would enable the LIHTC program to better serve renters with the lowest incomes and communities with the greatest needs.

While LIHTC is the nation's largest source of financing for affordable rental homes, the tax credit does not typically make homes affordable to extremely low-income (ELI) renters making at or below 30% of Area Median Income—those who face the greatest shortage of affordable homes and are at the greatest risk of homelessness. Unless ELI renters in LIHTC properties receive additional support, such as Housing Choice Vouchers, they are <u>likely to be severely cost-burdened</u>.

The National Low Income Housing Coalition (NLIHC) and partner organizations are advocating for three pivotal <u>reforms</u> to LIHTC: 1) an expansion of the ELI basis boost, which incentivizes developments that set aside at least 20% of units for ELI households or those exiting homelessness, and 2) the designation of Tribal areas and 3) rural areas as Difficult to Develop Areas, which makes them automatically eligible for a basis boost and therefore makes development more financially feasible in these areas.

The House Ways and Means Committee held a <u>markup</u> and vote on the tax package on January 19, and the bill passed out of committee on a vote of 40-3. Notably, Representative Gwen Moore (D-WI-04) was one of three representatives to vote against the bill, <u>calling it a "missed opportunity"</u> and highlighting its failure to help Tribal communities.

While the package that passed out of committee does not include key LIHTC reforms, the legislation has not yet passed the full House or the Senate, and it is not too late to take action! Advocates should <u>continue to push their members of Congress</u> to adopt key reforms that would equip LIHTC to better serve people with the greatest housing needs.
