






- Who are the parties?



# Waiting




- Mandatory waiting period

- Prepare for the final hearing


## Final hearing



#### **Adversity Scale**



- What are some reasons that the legal system might not work well for someone?
- Scale 1 4 [1 = minimal adversity faced; 4
   = highest level of adversity faced]
- Adversity score's impact on outcomes
  - Roll above adversity score: good outcome
  - Roll below adversity score: bad outcome
  - Roll below adversity score 3 times: divorce is dismissed



Leslie and their spouse have been married for 17 years.


They have two children, Jesse (16 years old) and Sawyer (4 years old).

Leslie's spouse, Pat, exercises sole control over the family's finances, but when their youngest child was born Pat's behavior began to escalate.


Leslie has decided to leave.




