



City Government Structure




County Government Structure

Most are open to the public



Minimized egos

Want to be the hero of an issue

Key Local Relationships

Mayors and County Executives

- Prioritize their staff
- Invite them to your events and centers
- They like tours and any media attention

City Council Presidents and County Board chairs

- Often has the most influence on the council
- Invite them to events

Committee Chairs

- Finance (typically the most powerful)
- Health and Human Services (has the biggest budgets)
- Other committees relevant to your work

Craft your message

- Clear and compelling message
- What is the problem
- Who is impacted by the problem
 - Use data
 - And personal stories
- Tailor your messages to the values and priorities of your local government officials
- What is your proposed solution
- What is your ask

Engage the community

- Create awareness about problem and proposed solutions
 - Social media
 - Local newspapers or other news outlets
 - Community gatherings (Farmers markets and festivals)
 - Encourage neighbors to get involved
 - A united community voice is a powerful force that can influence local decision-makers
